

# Information about the CLA Media Consultancy Licence

The CLA Media Consultancy Licence (MCL) provides permission for PR firms, communications agencies and consultancies to supply their clients with copies of articles from thousands of magazines and websites.

Whereas our 'Business Licence' covers the copying and reuse of published material for internal purposes, the MCL is additionally required if you supply articles externally to your clients.

The MCL enables the supply of:

- Hard copies of articles
- Digital copies of articles via e-mail
- Web-links plus a headline or article extract of up to 256 characters via e-mail

Content supplied under the licence can be copied by/received via a media monitoring service and forwarded to your clients.

## Information to give to your clients:

As part of the licence terms and conditions, Media Consultancy Licence holders are required to provide details of all clients supplied with articles. If you do not already hold a CLA licence, CLA will make contact regarding your requirements in respect of copying and reuse of licensed publications.



## Information for MCL holders to give to their Clients:

When your clients are sent copies, they can access and reuse this content in the following ways:

### Paper copies from print publications

- A client can receive a single paper copy of content licensed by CLA.
- If a client makes further copies, a CLA Licence is required. The Licence also allows the client to create a digital copy by scanning.

### Digital copies from print publications

- A client can receive a single digital copy of an article via e-mail. Once received, an article can be accessed only once and a single paper copy printed. Once accessed, the client isn't permitted to retain the digital copy and it must be deleted. Forwarding or saving the digital copy isn't permitted.
- If the client holds a CLA Licence, the digital copy can be saved, stored and forwarded internally within their organisation.
- Other terms and conditions apply – the client should refer to their specific CLA Licence for details.

### Snippet Links from online publications

- A client can receive a snippet link (a web link plus an extract of up to 256 characters) from an online article. The client isn't permitted to forward the snippet link internally or to copy, save or reuse the corresponding online article.
- If the client holds a CLA Licence, they may forward a snippet link internally and can make and store copies of the corresponding online article.
- Other terms and conditions apply – the client should refer to their specific CLA Licence for details.

### Statement for client use

This statement can be used for material provided to clients to advise them on the conditions of supply:
